MODE OF MEETING

The 47th AGM will be conducted online from the Broadcast Venue through live streaming using the Remote Participation and Voting ("RPV") facilities provided by the Share Registrar, Metra Management Sdn. Bhd. ("Metra"). This is in line with the Guidance Note and FAQs on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia on 18 April 2020 and revised on 7 April 2022 (including any amendments that may be made from time to time).

The Broadcast Venue, which is the main venue of the 47th AGM, is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 and Clause 58 of the Company's Constitution, which require the Chairman of the meeting to be present at the main venue on the day of the meeting. Hence, no member(s)/proxy(ies)/corporate representative(s)/attorney(s) from the public should be physically present nor will be admitted at the Broadcast Venue on the day of the 47th AGM.

REGISTRATION FOR RPV AT THE 47TH AGM

(1) Individual Members, Corporate Representatives, Proxy Holders, Authorised Nominees or Exempt Authorised Nominees, you are invited to attend the 47th AGM to exercise your right to attend, participate and vote at the meeting remotely by using the RPV facilities at <u>www.metramanagement.com.my</u> (Domain Registration No. D1A403946). You are required to do so by registering yourself using the RPV Platform in accordance with the instructions set out under Paragraph (3) below.

On the RPV Platform, you may exercise your rights as a Shareholder to participate (including to pose questions to the Board of Directors ("**Board**")) and vote at the 47^{th} AGM.

- (2) If a member is unable to attend the 47th AGM, he/she is encouraged to appoint the Chairman of the Meeting as his/her proxy and to indicate the voting instructions in the Form of Proxy in accordance with the notes and instructions printed therein.

- If you are already a user with the Metra Portal, you are not required to register again.

- Login with your user ID and password for remote participation at the 47th AGM at any time from 9:00 a.m., i.e. 30 minutes before the commencement of the 47th AGM.
- If you have forgotten your password, you can reset it by clicking on "Forgot Password".
- Select <<My Virtual Meeting>> under Main Menu.
- Click <<Join Meeting>> in order to join the live streaming of the 47th AGM.
- If you have any question(s) (in the form of typed text) during the meeting, you may use the Q&A platform in Zoom Cloud Meetings App to submit your question(s). The Board and senior management will try to respond to questions submitted by you during the 47th AGM. If there is time constraint in answering the questions, the responses will be emailed to you after the meeting.
- If you are using a smartphone to participate in the meeting, please download Zoom Cloud Meetings App from the Google Play Store or App Store before the meeting.
- Please take note that the quality of the live streaming is dependent on the bandwidth and stability of the internet connection at your location and the device you use.
- Please select the <<Voting>> option located next to <<Join Meeting>> to indicate your votes for the resolutions that are tabled for voting.
- Voting session will commence once the Chairman declares that the voting platform is activated. The voting session will end upon declaration by the Chairman.
- Please cast your vote on all resolutions as appeared on the screen and submit your votes. Once submitted, your votes will be final and cannot be changed.
- The RPV facilities will end and the Q&A platform will be disabled the moment the Chairman announces the closure of the 47th AGM.

PROXY

The 47th AGM will be conducted on a virtual basis. If you are unable to participate in the 47th AGM, you may appoint the Chairman of the Meeting as proxy and indicate the voting instructions in the Form of Proxy.

(i) In hard copy form:

- Attorneys appointed by power of attorney are to deposit their power of attorney to *The Company Secretaries of Magnum Berhad* not less than 48 hours before the time appointed for holding the 47th AGM or any adjournment thereof, in order to participate in the 47th AGM via the RPV Facilities.
- Shareholders who have appointed a proxy or attorney or authorised representative to participate at the 47th AGM via the RPV Facilities must ensure that his/her proxy or attorney or authorised representative register himself/herself at the Metra Portal prior to the 47th AGM.

(ii) By electronic means:

For option (ii) above, the Company may request any member to deposit his/her original executed Form of Proxy to its Registered Office before or on the day of meeting for verification purpose.

POLL VOTING

- 1. The voting at the 47th AGM will be conducted by poll in accordance with Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad. The Company has appointed its Share Registrar, Metra, as a Poll Administrator to conduct the poll by way of online remote voting using the RPV Facilities and Symphony Corporate Services Sdn. Bhd. as Scrutineers to verify the poll results.
- The online remote voting session will commence once the Chairman declares that the voting platform is activated. The voting session will end upon declaration by the Chairman. Please refer to item (v) above for the online remote voting procedures using the RPV Facilities.
- 3. Upon completion of the voting session, the Scrutineers will verify the poll results followed by the declaration of results by the Chairman.

REVOCATION OF PROXY

If you have submitted your Form of Proxy and subsequently decide to appoint another person or wish to participate in the 47th AGM by yourself, please write in to *The Company Secretaries of Magnum Berhad* to revoke the earlier appointed proxy not less than 48 hours before the time appointed for holding the 47th AGM or any adjournment thereof.

RECORDING

Unauthorised recording of the proceedings of the 47th AGM is strictly prohibited.

RECORD OF DEPOSITORS ("ROD") FOR THE 47th AGM

Only shareholders whose names appear on the ROD as at **<u>10 MAY 2023</u>**, shall be entitled to participate or appoint proxy(ies) to participate at the 47th AGM via the RPV Facilities.

NO DOOR GIFT

There will be NO DISTRIBUTION of door gift or e-vouchers for participating in the 47th AGM.
