#### MODE OF MEETING

In view that COVID-19 remains a threat to our health and safety, the 46th AGM will be conducted virtually through live streaming and online remote voting from the Broadcast Venue. This is in line with the Guidance Notes and FAQs on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia on 18 April 2020 and revised on 16 July 2021 (including any amendments that may be made from time to time).

The Broadcast Venue is in line with Section 327(2) of the Companies Act 2016 which stipulates that the Chairman shall be at the main venue of the 46th AGM. Hence, NO SHAREHOLDERS/PROXIES/AUTHORISED REPRESENTATIVES from the public will be allowed to be physically present at the Broadcast Venue on the day of the 46th AGM.

All shareholders of the Company, whether Individual Shareholders, Corporate Shareholders, Proxy Holders, Authorised Nominees or Exempt Authorised Nominees who wish to attend the 46th AGM will have to register to attend remotely by using the Remote Participation and Voting ("RPV") Platform, the details of which are set out below.

### RPV

- (1) The 46th AGM will be conducted entirely through live streaming and online remote voting. Should you wish to attend the 46th AGM, you will be required to do so by registering yourself using the RPV Platform in accordance with the instructions set out under Paragraph (3) below.
  - With the RPV Platform, you may exercise your rights as a Shareholder to participate (including to pose questions to the Board of Directors ("Board")) and vote at the 46th AGM.
- (2) If a shareholder is unable to attend the 46th AGM, he/she is encouraged to appoint the Chairman of the Meeting as his/her proxy and to indicate the voting instructions in the Form of Proxy in accordance with the notes and instructions printed therein.
- (3) The procedures for the RPV in respect of the live streaming and remote voting at the 46th AGM are as follows:

# Procedures

# Before the day of the 46th AGM (i) Register as a User

#### Action

- Please access the Portal of the Company's Share Registrar, Metra Management Sdn. Bhd. ("Metra"), at www.metramanagement.com.my
- Click <<Login/Register>> followed by <<Register</li>
   New User>> to register as a new user.
- Complete the registration by filling up the information required and upload a clear copy of your MyKAD (both front and back page) or Passport.
- Read and agree to the terms & conditions and thereafter, submit your registration.
- Please enter a valid email address in order for you to receive the verification email from Metra.
- Your registration will be verified and approved by Metra. Once approved, an email notification will be sent to you.
- If you are already a user with the Metra Portal, you are not required to register again.
- You may pre-submit your questions to the Board prior to the 46th AGM by emailing to MBAGM2022@magnum.my not later than 9:30 a.m. on 18 May 2022.
- Login with your user ID and password for remote participation at the 46th AGM at any time from 9:00 a.m., i.e. 30 minutes before the commencement of the 46th AGM.
- If you have forgotten your password, you can reset it by clicking on "Forgot Password".
- Select <<Virtual Meeting>> under Main Menu.
- Click << Join Meeting>> in order to join the live streaming of the 46th AGM.
- If you have any question(s) during the 46th AGM, you may use the Q&A platform in Zoom Cloud Meetings App to submit your question(s). The Chairman of the 46th AGM ("Chairman")/Board/Management will try to respond to all relevant questions submitted during the 46th AGM. If there is time constraint in answering the questions during the 46th AGM, we will respond directly to you at the earliest possible time after the end of the 46th AGM.
- If you are using a smartphone to participate in the 46th AGM, please download Zoom Cloud Meetings App from the Google Play Store or App Store before the 46th AGM.
- Please take note that the quality of the live streaming is dependent on the bandwidth and stability of the internet connection at your location.
- Please select the <<Voting>> option located next to <<Join Meeting>> to indicate your votes for the resolutions that are tabled for voting.
- Voting session will commence once the Chairman declares that the voting platform is activated. The voting session will end upon declaration by the Chairman.
- Please cast your vote on all resolutions as appeared on the screen and submit your votes. Once submitted, your votes will be final and cannot be changed.
- The RPV Facility will end and the Q&A platform will be disabled the moment the Chairman announces the closure of the 46th AGM.

#### **PROXY**

- 1. The 46th AGM will be conducted on a fully virtual basis. If you are unable to participate in the 46th AGM, you may appoint the Chairman of the Meeting as proxy and indicate the voting instructions in the Form of Proxy.
- 2. If you wish to appoint proxy(ies) to participate in the 46th AGM using the RPV Facility, please submit your Form of Proxy to the following address not less than 48 hours before the time appointed for holding the 46th AGM or any adjournment thereof, otherwise the Form of Proxy shall be treated as invalid:

- 3. Corporate representatives of corporate shareholders must deposit their original certificate of appointment of corporate representative to **The Company Secretaries of Magnum Berhad** not less than 48 hours before the time appointed for holding the 46th AGM or any adjournment thereof, in order to participate in the 46th AGM via the RPV Facility.
- 4. Attorneys appointed by power of attorney are to deposit their power of attorney to **The Company Secretaries of Magnum Berhad** not less than 48 hours before the time appointed for holding the 46th AGM or any adjournment thereof, in order to participate in the 46th AGM via the RPV Facility.
- 5. Shareholders who have appointed a proxy or attorney or authorised representative to participate at the 46th AGM via the RPV Facility must ensure that his/her proxy or attorney or authorised representative register himself/herself at the Metra Portal prior to the 46th AGM.

#### **POLL VOTING**

- 1. The voting at the 46th AGM will be conducted by poll in accordance with Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad. The Company has appointed its Share Registrar, Metra Management Sdn. Bhd., as Poll Administrator to conduct the poll by way of online remote voting using the RPV Facility and Symphony Corporate Services Sdn. Bhd. as Scrutineers to verify the poll results.
- 2. The online remote voting session will commence once the Chairman declares that the voting platform is activated. The voting session will end upon declaration by the Chairman. Please refer to item (v) above for the online remote voting procedures using the RPV Facility.
- 3. Upon completion of the voting session, the Scrutineers will verify the poll results followed by the declaration of results by the Chairman.

# **REVOCATION OF PROXY**

If you have submitted your Form of Proxy and subsequently decide to appoint another person or wish to participate in the 46th AGM by yourself, please write in to **The Company Secretaries of Magnum Berhad** to revoke the earlier appointed proxy not less than 48 hours before the time appointed for holding the 46th AGM.

#### RECORDING

Unauthorised recording of the proceedings of the 46th AGM is strictly prohibited.

### RECORD OF DEPOSITORS ("ROD") FOR THE 46th AGM

Only shareholders whose names appear on the ROD as at <u>6 MAY 2022</u>, shall be entitled to participate or appoint proxy(ies) to participate at the 46th AGM via the RPV Facility.

#### NO DOOR GIFT

There will be NO DISTRIBUTION of door gift or e-vouchers for participating in the 46th AGM.
